- ensure the safe use, handling, and storage of plant (equipment), structures and substances
- provide adequate facilities for the welfare of workers in carrying out work
- provide any information, training, instruction, or supervision that is necessary to protect all people from risks to their health and safety arising from work activities
- ensure that the health of workers and the conditions at the workplace are monitored to prevent illness or injury
- consult with workers on all matters relating to health and safety

# Workers

While at work, our workers will:

- take reasonable care for their own health and safety
- take reasonable care that what they do, or what they do not do, does not adversely affect the health and safety of other people
- comply (so far as they are reasonably able to) with any reasonable instruction given by management
- co-operate with any reasonable policy or procedure for work health or safety that has been communicated to them
- not misuse or interfere with anything provided for work health and safety
- report all incidents and near misses immediately, no matter how trivial
- engage in consultation with management to identify, assess and control hazards and the effectiveness of such controls
- report all known or observed hazards to their supervisor or manager.

# Contractors

All contractors and sub-contractors engaged by the company are responsible for:

- Complying with all contract conditions with respect to health and safety, including all statutory Health and Safety Acts, Regulations, codes of practices and guidelines
- Ensuring that their Health and Safety Plan has been approved by the company prior to starting work
- Providing adequate training and documented evidence to demonstrate that all employees can perform the tasks expected of them proficiently and safely
- Providing competent supervision to employees under their jurisdiction always

This policy applies to all business operations and functions, including those situations where workers are required to work off-site. We seek the co-operation of all workers, contractors, visitors, and others who may be affected by our business or undertakings. Furthermore, we encourage and support suggestions to create a safe working environment.
